Square Roots Community Partnership, Inc., d.b.a Square Roots Community Initiative (SRCI), has identified a need to provide more historical, cultural learning and hospitality/entertainment services to the Kennett Square area, specifically with an emphasis on elevating the stories of the Underground Railroad. SRCI's Creamery of Kennett Square Restoration project (Project) will address these issues by restoring the structural integrity of a historic building, so that it can be returned to productive economic and community use and to create a sustainable revenue source that can be deployed for charitable uses to improve greater Kennett Square. Ultimately the space is to include a cocktail bar and lounge, commercial Kitchen and event space that will all be designed to pay nomage to the stories of the Underground Railroad. The Project is expected to create up to 43 temporary construction jobs and \$206K in 1-time tax revenue generation; and 24 permanent jobs and \$129K in yearly tax revenue.

What will this project entail?

While the Creamery is operational and has realized tremendous success, approximately 19,000 square feet of space remains unusable. Redevelopment has been hampered by the lack of structural integrity in the remaining portions of the building. The structure consists of a concrete slab on grade, including concrete columns and beams supporting an elevated slab, and an additional level supported by wood framing. The Project involves the stabilization of the first floor, i.e. the elevated slab, of the rear section of the Creamery complex.

Specifically the RACP scope consists of improvements to the structure, including repairs to the concrete, masonry, wood, steel, and water management systems on the first floor of the building to restore the structural integrity.

How do you plan to use the funds?

Currently, the structural integrity of this portion of the Creamery building is compromised. As a result, an estimated additional \$2.4 million must be invested to stabilize the space before it can eventually be renovated, occupied, and used to its planned potential. This creates an immediate funding gap that directly hinders the financial feasibility of this project.

As such, SRCI is requesting \$2 million in RACP funding to restore the structural integrity of the Creamery building's first floor. As shown on the included RDA forms, SCRI will use the Creamery's land and building value as match, and also provide \$381,658 in construction investment to complete the Project. RACP and match funds will be used to repair the concrete, masonry, wood, steel, and water management systems on the first floor of the building.

What were the factors that the Candidate relied on to arrive at the requested amount?

SRCI was moving forward with renovation plans for the space in 2021 when it unexpectedly found evidence that the structure was unstable. SRCI employed the services of The Falcon Group — an engineering and architectural firm — to investigate the structural integrity of the Creamery. Once it was confirmed that significant structural repairs would need to be completed in order to eventually advance future renovation and fit-out, the extensive costs halted any forward progress. In order to ultimately return the space to productive economic use and create tangible benefits for local community non-profite, the cost prohibitive structural repairs must be received. The estimated costs

of more than \$2 million for the structural repairs have been outlined in the budget narrative. SRCI does not have the funds to complete the structural restoration and is therefore requesting \$2 million in RACP funding to support this effort.


